# <u>Lidl Plus Digital Vouchers, Lidl, Moycullen, Galway, Republic of Ireland - Terms &</u> Conditions

#### 1. Overview

Lidl Ireland GmbH, Main Road, Tallaght, Dublin 24 is sharing Lidl Plus digital monetary vouchers to spend at Lidl, Moycullen, Galway, Republic of Ireland from Thursday 27.02.2025 to Wednesday 02.04.2025.

## 2. Eligibility

The digital monetary vouchers are only accessible to registered Lidl Plus members shopping at Lidl, Moycullen, Galway. To use the digital monetary vouchers, you must:

- Be a registered Lidl Plus user. You can download the Lidl Plus app from the "App Store" or "Google Play Store".
- Set your Lidl Plus country to Republic of Ireland in the app.
- Be of a minimum of 18 years of age.
- Select "Lid! Moycullen" as your favourite store in the Lid! Plus app.
- Activate the digital monetary voucher before going to the till.
- Scan your Lidl Plus card at the till to redeem the digital monetary voucher.
- Complete a qualifying transaction at Lidl Moycullen, Galway.

## 3. Digital Vouchers

- From Thursday 27.02.2025 5 (five) digital monetary vouchers will be available in the "Treats" section of the Lidl Plus app for customers who have Lidl Moycullen selected as their favourite store in the Lidl Plus app.
- Each digital voucher will offer the customer €10 off with a minimum spend of €50 or more, minus standard exclusions.
- Only 1 x €10 off €50 digital voucher will be available to redeem per week over a 5-week period from Thursday 27.02.2024 to Wednesday 02.04.2025.
- Each €10 off €50 digital voucher will have a specific validity period which is displayed on the voucher and if unused after this date, they will disappear from your Lidl Plus app.
- Customers must redeem all 5 digital vouchers, starting from week commencing Thursday 27.02.2024 to avail of the full "€50" saving that is advertised.
- Some products are excluded from qualifying for the minimum spend of €50 to avail of the €10 discount on the digital vouchers such as alcohol, lottery, newspapers, medicines, gift cards, infant milk formula, mobile top-up, checkout bags and DRS deposits.
